The journal Contemporary Psychology is primarily intended for psychodiagnostic theory and practice and general psychological themes. It is the official journal of the Croatian Psychological Society.

The Editorial Board accepts unpublished manuscripts, written in the Croatian or English languages. The Editorial Board reserves the right to edit the manuscript in accordance to journal policy and standards of the Croatian and English languages.

Review process

All manuscripts received are subject to editorial reading and assessment of their acceptability to the journal, followed by a double-blind peer review, where the identities of the authors or reviewers are unknown.

Before submitting manuscripts, authors are asked to remove all identifying marks

from the text and references which could reveal their identity (name, project information) and to remove information from electronic files found in the properties section of the file.

Upon completion of the review process, authors need to include a cover letter with the revised manuscript, indicating which suggestions were accepted and how and which were not.

Copyright

The publisher reserves the copyright for articles published in the journal, both in print and electronic form. Articles published in the journal can be uses royalty free for educational, research and other non-commercial uses. The authors reserve their rights.

In accordance with the APA Publication Manual (2010), The Publication Process in Chapter 8 indicates that authors go through the points of the 'Check your manuscript' (APA, 2014, Checklist for Manuscript Submission, available at http://www.apa.org/pubs/authors/manuscript-check.aspx)

Point 8.04 states that "It is the author's responsibility to (a) obtain letters of permission from copyright holders to reproduce copyrighted material and (b) enclose copies of these letters with the accepted manuscript" (pp 231).

Research ethics

Research needs to be conducted in accordance with ethical rules and codes for conducting studies. The author may be asked to provide proof that the study was approved by an ethics committee of the relevant institution.

AUTHORS ARE ASKED TO OBSERVE THE FOLLOWING

Manuscripts:

- 1. The manuscript (including notes, bibliography and illustrations) should not exceed the given standards (1 text card equals 1800 characters with spaces)
 - Original Scientific papers 16 text cards
 - Preliminary Communication 8 text cards
 - Review Article 48 text cards
 - Professional Paper 16 text cards
- 2. The name of the author, institution name and address, e-mail address and title of the paper (in capital letters) is to be placed on the title page (the editors will erase these details for review purposes).
- 3. The journal uses the APA style of references in the text and reference list (http://www.apastyle.org/)
- 4. The reference list must contain full details of works mentioned in the text and cannot contain works not cited in the article.
- 5. References are cited in alphabetical order by author surname and in chronological order for the same author. If multiple works of the same author are cited with same year of publication, they need to be marked with letters (a, b, c etc.) following the year. In cases

of more than one author, all authors need to be listed, the et al form is not used.

- 6. The manuscripts must contain an abstract in Croatian and English. The abstract should not exceed 1800 characters with spaces and should contain the aim of the work, methodology employed, the most important results and a conclusion. Five key words need to be included.
- 8. Illustrations and tables should be prepared in accordance with the journal format.

Article categorization

Original scientific paper contains unpublished results of original scientific research, where the information is presented in such a way that the accuracy of the analyses and procedures upon which the results are based can be verified.

Preliminary Communication contains unpublished results of an ongoing study which are preferably quickly published. It is not necessary to present enough data for duplication and verification of results.

Review article contains an original, concise and critical review of an individual field or segment where the author is active. The author's role and contribution in the chosen field needs to be presented with respect to previously published materials and contain a review of these works. A review article contains state-of-the-art reviews. It can be written by one or several authors and is usually commissioned by the editor. The Editorial Board reserves the right to reject individually sent contributions.

Professional Paper contains published research results and focuses on their application in practice or their dissemination (educational purposes). A professional paper presents use-

ful, practical data not related to the author's research and the observations need not be necessarily new in the field. They must be written in a systematic and understandable manner, in accordance with reader profiles.

Miscellaneous – The Miscellaneous section of the journal accepts contributions about discussions, test reviews, book reviews, research project reviews, notes from the history of psychology, reports from psychology conferences and conferences from related fields with the participation of psychologists, conference announcements etc. A maximum of 8 text cards is recommended.

Authors are obliged to provide written permission for the use of any psychological instruments described in their work. Copies of permissions from publishers or authors are acceptable. Instruments in the public domain need to be accompanied by screen shots with relevant data. Please see the American Psychological Association criteria for the use of psychological tests:

References in accordance with APA style:

Sources need to be listed in the text, not as footnotes. The reference is in parentheses and contains the surname of the author, year and, in case of citations, the page number.

If an article has two or more authors, the surnames of both authors should be listed, followed by the year of publication. If an article has three or more authors, the surname of the first author is cited followed by et al., except when difficulties would arise due to several references with the same authors and years of publication. In such cases, surnames are listed until a different author is reached.
